10. After one to two weeks, all communication stops
11. The website disappears and reappears under a new domain name
12. Your contact information is sold to other scam operations

Recognizing Illegal Oxycontin Websites

Illegal websites use specific tactics to appear legitimate while operating outside all laws.

Absolute red flags for Oxycontin sellers:

- Claims of "express lane" or "instant secure access" without prescription
- No prescription required at any point in checkout
- Prices dramatically lower than market rates (under \$10 per pill)
- Payment limited to cryptocurrency, wire transfer, or gift cards
- No physical address or pharmacy license displayed
- No pharmacist available for consultation
- Website created within the last year
- Shipping from international locations
- Claims of "reliable track" without verification

What illegal sellers actually deliver:

1. Nothing at all after payment is processed
2. Fake tracking numbers with no actual shipment
3. Counterfeit pills containing fentanyl or other lethal substances
4. Expired medication that has degraded
5. Completely different drugs than what was ordered

Legitimate Oxycontin Access for Severe Chronic Pain
